

TENANCY APPLICATION FORM

PROPERTY ADDRESS.....

- There is a £250 plus VAT administration fee payable per property. This is payable in two installments, half when you apply as a "reservation fee" and the balance when you sign the tenancy. The first £150 payment will be required before referencing. Payment can be made by BACS, card or cash. If payment is made by cheque, the cheque will need to have cleared before referencing commences. Should the Landlord decide not to rent out the property after your application has been received, then this would be refunded to you. If the Landlord/Agent decides that your references are insufficient or unsuitable or you decide not to proceed after references have been sent out on your behalf, this amount will be retained by the Agents.
- □ When you sign the tenancy agreement you will need to pay the first month's rent and the deposit (normally equal to two month's rent). The deposit money will need to be cleared funds before you take the keys.
- Applications are not accepted on a first come first served basis. They are chosen on suitability at the discretion of the Landlord and their Agent. Should your application not be successful, the Agents are not required to provide a reasoned explanation.
- □ Any tenancy granted would be in the joint names of each applicant over 18 years old. In the case of married couples, tenancies will be placed in joint names. Any children over 18, still living at home, will be named as tenants and should be included on the application form.
- Please note that DHSS applicants are not accepted.
- □ Please note that applicants looking to **run a business from a residential property or to work from home** should check with our office before making an appointment to view.
- □ **Proof of identity**: Please bring a passport (in dated) or photographic driving licence (in date) and birth certificate into the office along with your application. These will be photocopied and returned to you. Please also bring a utility invoice in your name from the last three months (not a mobile telephone invoice).
- □ Please fill in **one** form per adult.
- □ What happens after your application has been submitted and accepted? We secure a reference through an online referencing company called HOMELET who will contact you by email to progress your application.
